- 1. SWEEPSTAKES PERIOD:** Sweepstakes begins April 1, 2018 at 12:00:00 a.m. Eastern Daylight Time ("EDT") and ends August 31, 2018 at 11:59:59 p.m. EDT (the "Sweepstakes Period").
- 2. HOW TO ENTER:** During the Sweepstakes Period, there are 2 ways to enter the Sweepstakes as described below.

**(a) TEXT MESSAGE:** Use your SMS-enabled mobile phone to text **GOSABRA** to **50563**. By texting GOSABRA to 50563, you authorize Administrator (defined in Section 4) to send up to seven (7) reply messages by autodialer to the number you provide. Entrants must have a mobile phone with text messaging capabilities to enter by Text Message and will be required to text their email address as part of the entry process. Consent is not a condition of entry. Your text is your electronic signature agreeing to these terms and to giving electronic written consent. Message and data rates may apply. Check with your wireless service provider for details on these and other applicable charges. Entrants are solely responsible for any such wireless charges. Not all wireless carriers participate. An entrant may, at any time, choose not to receive further text messages by sending an opt-out text message stating STOP to 50563. **(b) WEB SITE: To enter without sending a text message:** Visit [gosabra.com](http://gosabra.com) ("Web Site") and follow the instructions to complete and submit an online.

All entrants must have a valid email address. The name of the person submitting the entry into the Sweepstakes must be the name of the authorized account holder of the email address used to enter, otherwise, entry may be deemed void. In the event of a dispute over the identity of an entrant, entry will be declared made by the authorized account holder of the email address used during the submission process. A potential winner may be required to provide identification sufficient to show that he/she is the authorized account holder of such account.
